Who We Are

The Blockchain Insurance Industry Initiative (B3i) was incorporated as a limited company held by shares in March 2018 and domiciled in Switzerland. Its purpose is to develop solutions for the insurance industry built on blockchain technology.

The company has developed a Catastrophe Excess of Loss reinsurance contract which, after a successful test, was proved to offer material savings in the transaction value chain. As a result of further development, the product will be readied for live contracts at the end of 2018. The company has now commenced work on a Commercial Insurance proposition which will be delivered in 2019.

In addition to developing its own products, B3i will enable third parties to build and develop products, services, and solutions on the B3i platform through partnerships.

As more products and services are established and offered to customers, B3i will grow a network for insurance transactions through digitally enabled blockchain technology solutions. B3i expects this to become the largest ecosystem market for risk transfer in the world.





Our Vision

With this ambitious foundation, B3i has established a strong vision to accelerate the world's transition to more relevant, accessible and affordable insurance.

This will be achieved by growing the network and harnessing the power of the ecosystem founded on blockchain technology which will enable participants to create and share innovative solutions, products and services.

The Community Opportunity

B3i has created a Community Membership programme to enable companies to build a relationship with B3i and further their knowledge and experience of blockchain technology.

Membership is open to insurance market participants or organisations with a strong interest in the market who are committed to supporting the community and expanding the potential of using blockchain technology to improve the market.

Members will share the vision of B3i to accelerate the world's transition to more relevant, accessible and affordable insurance.

Conferences

B3i plans to hold three conferences per year. Initially these events will be held in North America, Europe and Asia. Further conferences will be added as we mature the membership programme.

Our conferences will be held over two days. The first day will be more general and informative with guest speakers. The second day will focus on the member and user community and cover topics related to the B3i platform such as product functionality, technology topics, business impact, strategic issues, new developments and product test outcomes. In addition, workshops will facilitate the discussion of potential joint use case development and other topics of interest.

Participating in these events will enable your organisation to learn and discuss the latest developments in Blockchain and gain experience from market ready Blockchain applications in insurance and beyond.

Your membership will provide free access for three employees per member company to each regional conference.

Think Tank

Blockchain is a very new technology which holds enormous potential but also challenges many current business models, regulations and market practices.

There are many strategies and questions yet to be considered as Blockchain developments become more prevalent. B3i is already taking a lead role in tackling many of these challenges for example, through engagement with regulators across the globe.

The B3i Community will create working groups to research and develop opinions on strategic issues. Through our thought leadership projects, members will be invited to participate in working groups. In some cases, members could take up leadership roles in these initiatives.

Members will gain advanced access to thought leadership, concept and positioning papers created through this forum as well as other documents from leading Blockchain and insurance experts. All intellectual property in the content is retained by B3i and may not normally be communicated to the media or disclosed externally without the prior consent of B3i.

In general, members will be approached to determine interest in new topics and will be able to nominate an employee to support an initiative. Such groups would not normally be larger than single figures. External experts may be involved where a certain specialism is needed.

Feedback Group

B3i values feedback from the market on its development programme beyond its customers. Members are important contributors in providing this feedback. B3i would like to consult its members in this way to ensure that developments are kept in line with new and emerging needs of the market and customers.

This forum will enable members to discuss and exchange information on product and technical development and act as a sounding board for B3i development teams. Your feedback could help to actively shape our development programme. In the future, testing facilities may be created for our latest developments.




This benefit will be facilitated through webinars, online meetings and conference events. In some cases, bespoke groups will be created by product owners in dedicated development bootcamps. Members are also encouraged to offer new ideas and use cases for development.

Participation in this benefit will be broader than in Think Tanks depending on the subject matter (e.g. technical, functional, strategy, business). Members will also benefit from access to subject matter experts and this could extend to potential secondment engagements with B3i.

As an extension to this, B3i will be able to offer more bespoke education and ideation workshops for its members. Drawing on our fields of expertise, client-site activities could be arranged to aid knowledge building or be more specifically focused on brainstorming solutions or co-creation opportunities.

This benefit is bespoke with a negotiable fee depending on the project, resource requirement and time.

B3i strongly believes in facilitating communication directly between its members. Derived from its experience in running its market testing programme, B3i recognises that strong benefits can be drawn from connecting members within the community.



Networking will take place during conferences and other events and in addition, members will be invited to join a digital communication channel. B3i has been using the Slack messaging tool since its inception and found this to be more effective than emails in many instances. Slack will be used initially for the Community network although this will be reviewed periodically to ensure that it remains effective compared with other tools.

Through this facility you will be able to pose questions, comments or circulate interesting information to B3i experts as well as Community members. Often, conversations develop in real time.

Access to the Slack messaging channel (or any subsequent tool) will be restricted to nominated employees who need to be registered by B3i. The aim is to create a network as wide as possible to maximise the potential of active users.

Pricing
